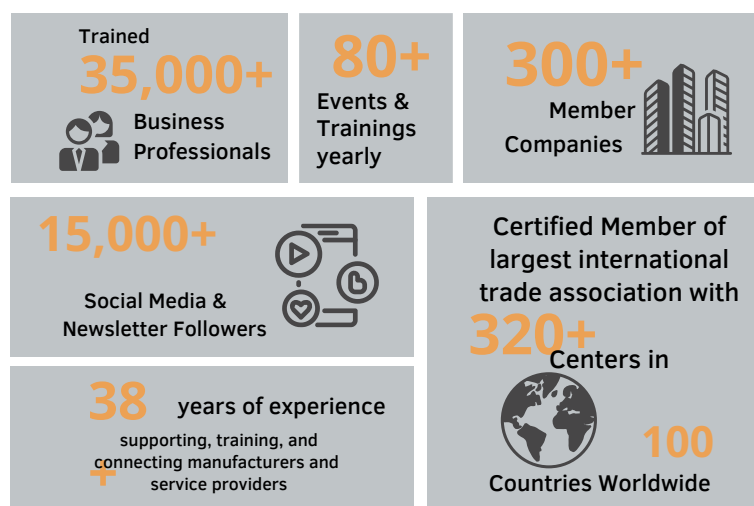

We issues Certificates of Free Sale for products manufactured and legally sold in the US. A Certificate of Free Sale states that the company selling the products has submitted evidence to us that the products listed on the certificate are freely sold in the US.

Certificate of Origin

Required by certain foreign countries for tariff purposes, the Certificate of Origin certifies the country of origin of specified goods. WTC Denver will notarize and authenticate the country of origin as a chamber of commerce. This is required for many certificates of origins with the exception of any NAFTA compliant certificate of origin. This service is free for Members.

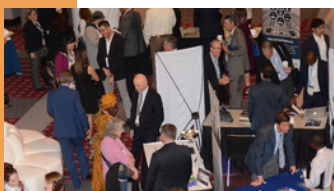
